The idea was initially conceived by **Professor Giuliano Amato**, Former Prime Minister of Italy and member of the Board of Directors of the EPLO. To that effect, in 2008 the **“Group of Rome”** was constituted around him and comprised of the most esteemed professors and practitioners. The ELGS academic program was officially presented at the Presidential Palace of the Italian Republic Il Quirinale, in the presence of H.E. The President of the Italian Republic Sergio Mattarella on May 18, 2016.

Scope and Goals

ELGS Governance and Faculty

The ELGS is honored to have the support and partnership of the world's most prestigious universities and to be under the leadership of the leading minds in law and governance scholarship. Honorary President of the Board of Trustees is Professor **G. Amato**, former Prime Minister of Italy. The Council of Representatives is presided by Professor **B. Mathieu**, University Paris 1 (Panthéon-Sorbonne), France. The Faculty Board is composed of the Dean, the Provosts, the Director General for Education of the EPLO and Heads of Departments when appropriate. **Luis María Díez-Picazo**, Judge at the Supreme Court of Spain and Professor of Constitutional Law is the Dean of the School.

UNDERGRADUATE DEGREE PROGRAMS

LLB in European Law (Athens & Rome Campus): A 3-year undergraduate program that strives to educate students on the key legal principles underpinning the EU. Students will be able to receive special training on a national law of their choice, as well as on transversal skills development.

BA in European Governance (Athens & Rome Campus): A flexible 3-year undergraduate program that provides students with a comprehensive understanding of the world of contemporary governance, with a focus on the European Union, and a cross-disciplinary grasp of its historic, institutional, legal, economic and political dimensions.

The **BA in European Law and Governance Studies (Athens & Rome Campus)** which is a combination of the above degrees.

POSTGRADUATE DEGREE PROGRAMS

LLM in EU Law (Athens-Rome Campus): This 1-year taught degree covers key topics related to EU law at the postgraduate level, such as the EU Area of Freedom, Security and Justice, and Competition Law. Students will have the unique opportunity to undertake a specialization in EU Monetary and Financial Law.

LLM in International Economic Law (Athens-Rome Campus): This 1-year taught degree is built upon three main pillars on Trade, Investment and Competition, aiming at tackling world economic affairs at the highest possible level, with participants coming from worldwide.

MA in Governance (Athens-Rome Campus): A 1-year degree program covering the latest approaches in global and national public policy-making and administration, political economy and global governance and institutions. Students will be able to select from an array of high-level elective modules ranging from professional trainings to specialized topics.

Master in Global Rule of Law and Democracy (conducted from the Cascais/Estoril campus in Portugal): This 1-year taught degree offers students an in-depth look at key issues on the Rule of Law. It is inspired by the UN System Framework and is supported by the EPLO Global Rule of Law Commission. Its main focus is to teach and inform students about how the Rule of Law is applied, protected and spread internationally.

New Master's with La Sapienza University: International Master on European and Comparative Public Law (Rome Campus)

RESEARCH DEGREE PROGRAMS Dissertation on their own language provided that the supervisor agrees.

Master of Studies: Designed to maximize students' ability to personalize their research studies, this 1-year program mobilizes Members of the ELGS International Faculty to motivate students to undertake research on a chosen topic within the greater fields of law and governance and to write their dissertation **in up to ten languages**. Completion of the MSt, grants the successful graduate, **the opportunity to transfer to PhD status (2nd year of PhD)** after the supervisor's approval and the **successful completion** of his thesis presentation and research methodology proposal to an ELGS member panel.

Doctor of Philosophy: The highest level of research to be conducted at the ELGS. Qualified students can apply for this 3-year research program, that enables them to undertake research on a topic of their choice within the greater fields of law and governance.
